Privacy Policy

What is the VIN?

The Holme-next-the-Sea Village Information Network (VIN) is owned, maintained and operated by the VIN controller, Tony Foster, a resident of the village. He can be contacted by email at villagenetwork@holme-next-the-sea.co.uk

The service is free, makes no profit and is non-commercial.

The VIN controller maintains close links with Holme-next-the-Sea Parish Council, which is a user of the service. All information distributed via VIN on behalf of the Parish Council will be clearly marked as such. All correspondence intended for the Parish Council regarding VIN notices should be sent directly to the Parish Clerk via email to holmentsparishcouncil@gmail.com

What information do we collect?

We collect the information you provide when you register with us - your name, postal address and email address. A secure log is kept of your consent to receive emails and a secure record is kept of all email exchanges between VIN subscribers and the VIN controller. All of your personal information will be deleted if you cease to be a subscriber to the VIN.

What do we use your information for?

Your name and email address is added to an email circulation list used exclusively to send out to the VIN subscribers a variety of information that may be relevant to anyone who has an interest in the village of Holme-next-the-Sea.

How do we protect your information?

All of the personal details that you have provided are securely held, password controlled and securely backed up, by one individual on a personal computer. We implement a variety of security measures to maintain the safety of your personal information. Emails sent to the VIN circulation list are sent BCC so that subscribers' email addresses are not made public.

Do we use cookies?

We do not use cookies when sending VIN email messages.

Do we disclose any information to third parties?

We will not sell, trade, or otherwise transfer to third parties your personally identifiable information. This does not include the companies who act as email carriers and whose networks are used to deliver the VIN emails to your email account.

From time to time the total number of subscribers to the VIN service will be given to Holme-next-the-Sea Parish Council. Just the number - no other information will be provided.

Your rights

The General Data Protection Regulation gives you rights as an individual regarding your personal information and data. You can:

- Ask to see a copy of your data
- Ask that any of your data is corrected or modified
- Ask that all of your data is deleted
- Object to the way your data is used
- Ask that your data be transferred elsewhere

All such requests should be emailed to villagenetwork@holme-next-the-sea.co.uk

We will attend to any such requests with minimal delay - usually within 24 hours.

Occasionally, at our discretion, emails sent by the VIN may contain links to third party websites or email addresses. These third party sites have separate and independent privacy policies. We therefore have no responsibility or liability for the content and activities of these linked sites. Nevertheless, we seek to protect the integrity of the VIN and welcome any feedback about these third party sites.

Online Privacy Policy only

This online privacy policy applies only to information you have provided by email, or via the village website of Holme-next-the-Sea at www.holme-next-the-sea.co.uk/vilinfnet.php
It does not apply to personal details collected offline.
